Payment Plans

Plan 1: Full year- one payment due in full before September 14, 2023. You will receive a 5% discount by choosing this plan. Spring recital fee is NO longer waived with this plan.

Plan 2: Quarterly- Beginning after initial September payment, Four equal installments: 1st quarter due October 1st with subsequent payments due December 1, February 1, and April 1.

Late Payments: Tuition will be considered late after the 15^{th} of the month (regardless of student attendance). A \$10.00 late fee will be added to your account. Additionally, balances carried over to the next month will be assessed a 10% of base tuition cost late fee. This 10% is in addition to the initial \$10.00.
